isa21's digital events will be held via the web conferencing tool Zoom. These events can be accessed only live and only by registered users. If you give a presentation, contribute actively to a discussion, or otherwise use Zoom's sound or camera functions during an event, you become part of the video and audio material that is being produced. This material will be made available by the mdw – University of Music and Performing Arts Vienna exclusively as a live stream via the streaming service offered by the mdw.

No recording or further processing will take place. Please also see our detailed isa's detailed Data Protection Declaration. If you do not wish to make your data accessible to other participants during the stream, please use a pseudonym when logging in and be sure to use neither Zoom's camera function nor its microphone function. The mdw, as host, has deactivated these functions as the default setting. You will only be able to contribute actively to a discussion once you have activated these functions yourself.

Information on data protection in connection with the use of Zoom as well as with video and audio material that involves participants in the 2021 International Summer Academy of the mdw in accordance with Art. 13 GDPR.

The mdw – University of Music and Performing Arts Vienna, Anton-von-Webern-Platz 1, 1030 Vienna, Tel +43 1/71155- O ("the mdw"), as the organiser of the 2021 International Summer Academy and the controller in the sense of the General Data Protection Regulation (GDPR), places great importance on the protection of your personal data and processes such data exclusively in conformance with applicable data protection laws.

Registration to Participate via Zoom

When you register for digital events of isa21, the personal data that you provide will be processed in order to register you for and conduct the respective events. This processing takes place on the basis of the contract thereby initiated and/or following confirmation of your successful registration on the basis of the initiated contract in accordance with Art 6 Sec 1(b) GDPR and/or in service of the public interest in accordance with Art 6 Sec 1(e) GDPR in connection with §§ 1-3 of the Austrian Universities Act (UG).

Use of Zoom

For the provision and conduct of the event, the mdw makes use of cloud-based speech and video services—in this case Zoom. The legal basis of data processing in connection with the COVID-19 epidemic is compliance with a legal obligation (Art. 6 Sec.1[c] GDPR in conjunction with the COVID-19 Measures Act in conjunction with related ordinances of the Federal Minister of Social Affairs, Health, Care, and Consumer Protection) as well as the protection of vital interests of the data subject or another natural person (Art. Sec. 1[d] GDPR) in connection with the simultaneous upholding of university operations and University administration. It also serves to fulfil the duties of care assumed by the mdw as an employer in accordance with Art. 6 Sec. 1(b) GDPR. A further legal basis for data processing is realisation of the principles and tasks of the University that lie in the public interest, Art. 6 Sec. 1(e) GDPR in connection with § 2 subparas 8, 13, and 14 as well as § 3 subparas 6-8, 11 UG.

Purpose and Legal Basis of Streaming (Live Broadcasting)

When you take part in an event via Zoom, the name under which you have registered—and, if you use your camera, your image—can be seen by the instructor and other participants during the event.

If you contribute actively to a discussion by using the camera and microphone functions, you can be seen and heard live by all participants in the event.





If you do not want to be personally identifiable in the live stream, please use a pseudonym when registering and refrain from using Zoom's camera and microphone functions. The mdw, as host, has deactivated these functions as the default setting. You will only be able to contribute actively to a discussion once you have activated these functions yourself.

The event will be broadcast exclusively via the live stream, and the processing of your data shall take place exclusively for the purpose of holding the digital event. Your data will not be saved, nor will they be processed for purposes other than live streaming itself.

The legal bases for doing so are performance of a contract in keeping with Art 6 Sec 1(b) GDPR (granting of rights), the public interest in keeping with Art 6 Sec 1(e) GDPR in conjunction with §§ 1, 2, 3 subparas 4, 8, 11 of the Austrian Universities Act (UG), or—insofar as the mdw is not acting to fulfil its responsibilities under public law—legitimate interests pursued by the controller in accordance with Art 6 Sec 1(f) GDPR. Processing takes place exclusively for the purposes indicated via the use of modern media (here: streaming) that employ this video and audio material. Use is made only in a way that is transparent and to the extent that it is necessary for this purpose. Appropriate technical and organisational measures for the purpose of protecting these data will, of course, be adhered to.

Recipients of Transmitted Data

The processing of your personal data is done first by employees of the mdw. The video and audio material featuring your person is used exclusively for teaching, documentary, and informational purposes during the associated events.

When you use Zoom, your data can also be transferred to a recipient in the United States of America (see provider's "Privacy Data Sheet"). Your Rights

As the data subject, you have the right to request from the mdw information about as well as the rectification, erasure, restriction of processing, and portability of your data in accordance with Art 15-21 GDPR. You are furthermore entitled to file complaints with a supervisory authority (in Austria: Austrian Data Protection Authority, dsb@dsb.gv.at) regarding data protection violations.
